Memorial Gift for Senior Golden Disc Honorarium

For the first time in Arcadia history, the Senior Golden Disc included an honorarium for the awardee, made possible by a thoughtful gift from Robert Ruskin. The gift, in memory of his late wife, Ann Smith Ruskin '84MEd, is not only a tribute to her, but also a beautiful way to commemorate the high honor that the Senior Golden Disc represents.

The Senior Golden Disc recognizes a graduating senior who exemplifies the highest standards of leadership, promotes the welfare of Arcadia, demonstrates a lasting commitment to the University, and inspires the respect and admiration of their classmates.

The Senior Golden Disc was awarded to Michael Johnson '24, who said this about the Disc's new honorarium: "Having an honorarium, along with the overall recognition and honor of the Senior Golden Disc itself, signifies to me that Arcadia and its community consistently work to find ways to truly acknowledge the hard work of students. I will use the honorarium toward my moving expenses to Washington, D.C., and purchasing what I will need to ensure a successful first semester at George Washington University where I am pursuing a Master's of Public Policy degree."



Philanthropy Supports Faculty Initiative for Students

Education Faculty Rebuild the Black Teacher Pipeline


Arcadia University was selected as a recipient of a grant in the amount of \$50,000 from the Center for Black Educator Development (CBED) to help rebuild the Black teacher pipeline. Only 18% of U.S. educators are teachers of color and 50+% of Pennsylvania schools are without any teachers of color. Since its formation in 2019, the CBED has worked with educators nationwide to advocate for racial justice and equity in education while also rebuilding the Black teacher pipeline.

Associate Professor of Education Dr. Marc Brasof (left), and Assistant Professor of Education Dr. Priscilla Jeter-Iles '99MEd, '09EdD (right) worked with University Advancement to secure this grant to strengthen the efforts of the Social Action and Justice Education (SAJE) Fellowship, which they lead. Addressing the nationwide lack of diversity and cultural competency in the teaching profession, Arcadia's Social Action and Justice Education (SAJE) Fellowship is designed to address financial, curricular, and social hurdles that discourage students of color from entering and eventually graduating from teacher education programs.

Specifically, this grant will support the SAJE first-year peer mentorship program, which Dr. Brasof says has led to the fellowship's significant retention rate by surrounding students with support. This program will be expanded to include returning SAJE fellows. The hope is to also have doctoral students in Arcadia's Educational Leadership program serve as mentors for undergraduate students pursuing teaching certifications.

The **Student Emergency Fund** provides financial assistance to students facing dire circumstances that threaten their academic progression. Funding directed here aims to mitigate unforeseen financial barriers that could hinder students' successful continuation of their academic pursuits.

Counseling Services can offer confidential counseling services and offset out of pocket expenses for students who need to seek off-campus treatment, including help to subsidize transportation costs, or providing copay assistance over and above what student insurance may not cover.

Stocking the **Knights Resource Pantry** over the summer and fall semester with household cleaning products and

personal hygiene products for both of its on-campus locations will aid students in need. The Knights Resource Pantry is completely dependent on the kindness of others and is 100% gift dependent to operate.

Focused on student recreation, this gift will also be used to purchase a new front desk and chair for the **Game Room**. This much needed face-lift will create a welcoming and functional space where students can relax, socialize, and engage in fun and recreational activities. A new front desk will serve as a central point for information and assistance and will also be the point of contact for the new Archie's Apparel, a one stop shop for gently used, no cost business attire for students who have interviews or are attending or presenting papers at conferences, and more.

Alumni House at Blankley Hall


A Gift of Love: Gift Preserves History for Today and Tomorrow

Built as the original gatehouse and servants' quarters for Grey Towers Castle on what was the Harrison Estate, the Alumni House at Blankley Hall has a story of its own to tell. Like the University, it has undergone several name changes and uses. Known first at The Gatehouse at the Harrison Estate, used as a first point of entry and welcome, in the University's care it has also been known as The Lodge, The French House, The Music Building, Blake Hall, and then in 2005, Blankley Hall. Today, The Alumni House at Blankley Hall has recently been transformed, thanks to the support of Life Trustee, Rosemary Deniken Blankley '57, '06H.

During the spring and summer months of 2024, The Alumni House at Blankley Hall underwent an interior revitalization, overhauling the carpets and ceilings, renovated restrooms, new paint, all while retaining its historic design flourishes. The aim was to not only provide appropriate work space for staff who will occupy the building, but to ensure that it was a home befitting our alumni community. In the fall of 2024, the historic building will once again house the Division of University Advancement. True to its name as "The Alumni House," almost reverting to its original purpose when it was the Gatehouse in 1898, it will serve as a welcome center for alumni when they return to their Alma Mater. Many alumni events will be held at this historic edifice, both indoors and outside on the cobblestoned entry pavilion and lush lawns.

The Alumni House at Blankley Hall will continue to be adorned with items of Beaver/Arcadia historical significance for alumni and other guests to enjoy and reminisce about when they visit, paying tribute to the University's legacy.

This upgrade of the 'gatehouse' is just one of many ways donors can support the beautification and historic preservation at Arcadia University. 

"I lost my mom last year," Janice said, "and I felt close to my mom by giving a special gift to Arcadia this year."


Janice has been a steadfast annual fund supporter of Arcadia since her graduation 35 years ago, and her increase in giving this year was more than just symbolic. "As I got older,

The Power of Estate Planning

Pauline Vaughan Hamilton '41, an education major, made her first gift to the then-Beaver College annual fund in 1985 in the amount of \$50. Her annual fund giving continued unabated in gifts of \$500 or \$1,000 for many years, until she passed away in 2001. Yet, Pauline Hamilton '41 was not done giving to her Alma Mater.

After her passing, the intensity of her pride became undeniably apparent. It was then that the Hamilton Estate disbursed its first gifts and established the Pauline V. Hamilton '41 Endowed Scholarship in 2001, designed to financially support students with demonstrated financial need. Through a series of realized bequests from 2001 to 2004, totaling \$1.1 million, her wishes came true. And for over twenty years, she has continued to provide financial aid for countless numbers of students. In 2024, another gift made its way through the Hamilton Estate in the amount of over \$350,000. Since 2001, her fund has grown to \$1.8 million but with her latest gift, her fund is sure to increase to well over \$2 million, providing \$80,000 in aid annually to students who need support.

By including Arcadia in her estate planning, Pauline V. Hamilton '41 became a member of the Covenant Society. Denis Brosnan, Associate Vice President of Philanthropic Giving at Arcadia, said, "I am profoundly grateful for gifts like that of Pauline V. Hamilton '41. Her generosity demonstrates a care for her Alma Mater, a clear signal of what she truly valued as well as a profound affection for students at Arcadia University that she knew she would never meet. Her appreciation for the education she received from Beaver College and the opportunities it afforded her in life were the influences in her decision to give. Her endowed scholarship now provides incredible access and educational opportunities for generations of students to come."
